IMPORTANT REGISTRATION POLICIES.



Policy re: non-payment of fees

In order to enter the dance studio and participate in dance instruction, dancers' fees must be paid in full according to the payment schedule outlined below.

- Monthly post-dated cheques for fees on file need to accompany Registration forms when registering for the dance year. They will be kept on file with the office and deposited during the first week of each month.
- Any other payments owing, such as costume deposit, registration fee, paid in full by date due.

Families will be notified immediately if at any time they have not met the above criteria and their children will be withdrawn from participation until all payments are met.

Policy re: safety outside of classroom

Veselka is not responsible for the safety of the dancers outside of the class time.

Policy re: withdrawal from dance program

Notice of withdrawal: Dancers may cancel their registration and withdraw from the dance program at any time before December 31st of the dance year and receive a prorated refund of registration fees paid. A non-refundable policy is in effect for Dancers who wish to withdraw from the dance program after January 31st. The Board of Directors will make exceptions for specific circumstances such as injury or family moves to another city. Dancers who are dismissed from the program will receive a prorated refund of any registration fees paid.

Parent volunteers are responsible for the administration of the Veselka Dance Association; your cooperation and support is very much appreciated.

VOLUNTEER COMMITMENT FORM VESELKA FAMILIES:

In order to keep dance fees as low as possible and to help pay for expensive costumes it is a requirement that all families participate in fundraising activities and committee work (up to 4 hours a month).

I further hereby voluntarily agree to waive my rights and that of my heirs and assigns to hold Veselka, its staff, agents, volunteers, assistants, employees, guest artists, faculty members, and/or students liable for such damage, loss, injury, or death. I understand that I should be aware of my physical limitations and agree not to exceed them. 1. Dancers are expected to pay attention to and follow the Dance Teacher's instructions and should not disrupt the class.
2. Dancers should not touch other dancers, or any members of Veselka Staff for any reason, except by consent, or in the dance performance choreography and in a dance routine.
3. Dancers are expected to attend classes regularly.
4. Dancers are expected to be punctual to avoid class interruptions. Dancers are expected to wear appropriate dance attire.
5. Dancers must treat the studios, the premises, and the possessions of all other dancers with respect, care, and consideration.
6. Dancers understand that there is a zero tolerance behavior policy at Veselka. Dancers behaving inappropriately will be removed from the dance class and parents/legal guardians will be involved in resolving the dancer's behavior problem.

Dancers and Parents/Legal Guardians:

7. Veselka Dancers and parents/legal guardians are expected to demonstrate respect for all Veselka staff and other dancers, visitors and parents/legal guardians at all times.
8. Dancers and parents/legal guardians observing a dance class are expected to be quiet and courteous to the practicing Dancers and the Dance Teacher.
9. Dancers and parents/legal guardians are expected to clean up after themselves, tidy the furniture, do the dishes, and clean up any mess that they create in the premise including the lounge area.
10. Dancers and their parents/legal guardians may raise any issues or concerns with the Dance Teacher. If there is no positive solution, they may raise their issues or concerns with Veselka staff or the Board of Directors.
11. Parents/Legal Guardians shall ensure that Veselka fees are paid.
12. Parents/Legal Guardian's shall inform the Dance Teacher promptly about absences or late arrivals, especially for a show.
13. Veselka is not responsible for supervision of dancers outside of the class time. Dancers should remain in the waiting areas with their parents/legal guardians until it is time for their class. Parents/Legal Guardian's must ensure pick up of dancers promptly after class ends.
14. Parents/Legal Guardian's are expected to assist their Dancer(s) to follow the Dancers' Code of Conduct.
15. Parents/Legal Guardian's shall help school staff deal with disciplinary issues involving their Dancer(s).
16. Veselka is not responsible for lost or stolen items. Please ensure safety of your valuables.
